

2019 ARA Contingency Program Details

Program Summary

Hoosier Racing Tires is a Contingency Sponsor of the American Rally Association and it is an optional contingency awards program.

Program Eligibility

The Hoosier Racing Tire Contingency Program will be available to all ARA Teams who pre-register in for any 2019 ARA Regional or National Rally of the year and run Hoosier Tires on their rally cars.

Eligible Classes

Competitors entered in the following American Rally Association (ARA) classes are eligible to participate in the 2019 Hoosier Tires Contingency Program:

- Open 4WD ARA Regional & ARA National
- Naturally Aspirated 4WD ARA Regional & ARA National
- Limited 4WD ARA Regional & ARA National
- Open 2WD ARA Regional & ARA National
- Limited 2WD ARA Regional & ARA National

Important Note: A minimum of five (5) competitors are required in a class to claim awards

National and Regional classes must have a minimum of Five (5) entries take the start or compete, per race, per class, to qualify for participation in the 2019 Hoosier Tire Contingency Program. If an ARA National Rally event weekend also hosts multiple Regional Rally events, the overall results from each Regional Rally run that weekend will be combined to determine placement for Hoosier Tire Contingency Program prizes.

- Hoosier Racing Tire retains the option to name and/or change eligible categories, classes, and cars at any time during the 2019 season.

Program Requirements

The following is required in order to participate in the 2019 Hoosier Tire Contingency Program:

- Competitor must race with Hoosier Racing tires on all four wheel positions.

- Correct Logo Placement:
 - One (1) 10"x3.5" on **each side** and one (1) 18" x 5" on center of the front and rear bumper.
 - No competing tire decals (or patches) may be visible on the car or the drivers suite. **No exceptions** will be made for this rule.
 - **Availability:** Decals will be mailed once registered. Additional decals are available by contacting Tim Gilvin at tgilvin@hoosiertire.com
- Contingency forms must be completely filled out and included all supplemental information; copy of official results, proof of purchase and photos.
 - Original proof of purchase must be made available to Hoosier if requested.
 - Tires must be purchased from an authorized Hoosier Racing Tire distributor or a Track Side Support Dealer.

Program Registration

Competitors who would like to participate in the 2019 Hoosier Tire Contingency Program at ARA Regional/ National Rally events must meet the requirements outlined above as well as the following registration requirements:

- Competitors must register each year to be eligible for awards
- Competitors must be registered in the program prior to competing. No awards will be paid if you do not follow all of the contingency procedures.

- Decals used must be the officially supplied Hoosier Decals.

Award Information

Hoosier Tires will be awarding prizes based on finishing results in each class, including:

1. First in Class – 4 free Hoosier Tires
 2. Second in Class – 3 free Hoosier Tires
 3. Third in Class – 2 free Hoosier Tires
 4. Fourth in Class – 1 free Hoosier Tire
- A maximum of four (4) tires will be awarded per vehicle, per race weekend.
 - Hoosier sponsored Rally Teams will not be eligible for contingency program.
 - Contingency awards are non-transferable and are redeemable for tires only.

- All awards must be claimed within 30 days of each eligible event.
- Upon prior approval, a team may request a Hoosier passenger or light truck product instead of a Rally Tire as an award replacement; subject to approval of rally program manager
- All awards must be claimed within a 30 day period after the Event
