Registration:	* Competitors must register each year to be eligible for awards. * Competitors must be registered in the program prior to competing. Class Eligibility List:	* Competitors entered in the following American Rally Association (ARA) classes are eligible to participate in the 2020 Hoosier Raicng Tire Contingency Program. * Open 4WD, Naturally Aspirated 4WD, Limited 4WD, Opend 2WD, Limited 2WD, UTV All ARA Regional & ARA National events. ("Stand Alone" Rally events are NOT eligible to be included in the contingency program)			
Requirements:	* Competitor must race with Hoosier Racing Tires on all four wheel positions and wear a Hoosier patch on their driving uniform. * Decals Required: YES * # of Decals: Four (4) * Location: One (1) 11" decal on <u>each side</u> and one (1) 11" decal on the <u>front</u> and <u>rear</u> bumper. No exceptions will be made for this rule. No competing tire decals, and decals must be contrasting colors from the race car. It is the competitor's responsibility to register properly and neatly apply decals. Decals used must be the officially supplied Hoosier Decals. * Availability: Decals and Patch, if needed, will be mailed if requested at registration. Additional decals are available by contacting Paula Nate at pnate@hoosiertire.com			
Award Information:	* Product awards are presented to all eligible 1st, 2nd, 3rd and 4th place drivers in the ARA RALLY ASSOCIATION competition. Requirements outlined above: DNS are not counted in the class count. * Contingency forms must be completely filled out and include all supplemental information; copy of official results, proof of purchase & photos. Original proof of purchase must be made available to Hoosier if requested. Tires must be purchased from an authorized Hoosier Racing Tire Distributor or a Track Side Support Dealer. Tires must be purchased at MSRP to be eligible for the contingency program. * A minimum of five (5) competitors are required in a class to claim awards. * Competitors may only submit claims for the same size tire for which they competed and which they can provide proof of purchase. * Hoosier sponsored Rally Teams will Not be eligible for the contingency program. Contingency awards are non-transfrable and are redeemable for tires only. * All awards must be claimed within 30 days of each eligible event. * See "Payout Schedule" below for award amounts.
