Class Eligibility List:	 Competitors entered in the following American Rallly Association (ARA) classes are eligible to participate in the 2022 Hoosier Racing Tire Contingency Program.
	 Any Open Competition Class. ("Stand Alone" Rally events are NOT eligible to be included in the contingency program)
Requirements:	 Competitor must race with Hoosier Racing Tires on all four wheel positions and wear a <u>Hoosier patch</u> on their driving uniform.
	 Decals Required: YES, Four (4) Location: One (1) decal on each side and one (1) decal on the front and rear bumper.
	No exceptions will be made for this rule. No competing tire decals, and decals must be contrasting colors from the race car.
	It is the competitor's Responsibility to register properly and neatly apply decals. Decals used must be the officially supplied Hoosier Decals.
	Availability: Decals and Patch, if needed, will be mailed if requested at registration. Additional decals are available by contacting Paula Nate at pnate@hoosiertire.com
Award Information:	* Product awards are presented to all eligible 1st, 2nd and 3rd place drivers in the ARA RALLY ASSOCIATION competition. Requirements outlined above: DNS are not
	counted in the class count. * Contingency forms must be completely filled out and include all supplemental information; copy of official results, car / decal photos.
	* A copy of a paid MSRP invoice is required and must accompany all redemption forms submitted. The maximum number of contingency tires that can be claimed is equivalent to the quantity of tires listed on a paid invoice, e.g. buy a set of four (4) Hoosier Tires and claim a maximum of four (4) contingency tires for that invoice. The invoice must be dated within 90 days prior of the event. Contingency awarded tires, random draw tires (i.e. no charge tires) or discounted tires will not be eligible for contingency claims.
	* A minimum of five (5) competitors are required in a class to claim awards.
	* Competitors may only submit claims for the same size tire for which they competed and which they can provide proof of purchase.
	* Hoosier sponsored Rally Teams will Not be eligible for the contingency program. Contingency awards are non-transferable and are redeemable for tires only.
	* All awards must be claimed within 30 days of each eligible event.
